

Irish Cider Market Report 2019

## Introduction

Drinks Ireland Cider, formerly the Irish Cider Association, has produced a cider market report to highlight the performance of the sector in 2019. The data in this report predates the impact of Covid-19 but it highlights the need for support for the sector as it faces uncertain times in the months and years ahead.

Cider drinkers in Ireland continue to enjoy an unprecedented selection of cider brands from both craft cider producers and some well-established drinks manufacturers, scattered throughout the country. However, total cider sales in 2019 decreased by 1.7% with over 63 million litres of cider sold. It is the first decline in sales since 2015. It is estimated that over 50,000 tonnes of apples are used every year to manufacture cider in Ireland. Per capita consumption of cider declined by 0.47% which is in line with an overall trend of total alcohol consumption decline.

Today, cider is still Ireland's third most popular alcohol beverage behind beer and wine, once the spirits category is split into its different variants (such as whiskey, vodka and gin). Cider's market share of total alcohol sales declined marginally from 7.5% in 2018 to 7.4% in 2019.

The performance of Irish cider exports in the last decade has been a cause for concern. However, 2019 saw a significant increase in exports by 32%, primarily driven by UK exports. A number of factors likely contributed to this increase in exports to the UK, ranging from resurgent consumer demand to preparatory planning and stockpiling for potential Brexit shocks. In 2019, it is estimated that 90% of Irish cider exports went to the UK. Uncertainty around Brexit and Covid-19 could impact on investment within the sector.

Like other alcohol variants, cider makes a significant contribution to the exchequer with just under €60 million worth of excise collected in 2019. Over the past decade it has contributed over half a billion Euro in excise alone to the exchequer. Irish cider consumers pay the third highest rate of excise on cider in the European Union. In fact, there is no excise charge on cider in 14 EU Member States. Considering the impact of the Covid-19 crisis and the prospect of cider tariffs arising from a 'No-deal' Brexit, Drinks Ireland | Cider calls on the government to lobby for cider to be part of the EU Excise Structures Exemption. This will enable craft cider producers to secure excise relief reductions that are similar to those enjoyed by the craft beer sector.

## **Cider consumption**
